## Takeaways from August 2 Research Meeting

(See attached notes and minutes)

Tracy led us through draft notes of the August 2 meeting (a copy is available from Chris).

The Board approved reimbursing Tracy \$135 for food and refreshments for what proved a very successful and useful event.

Tracy recommends scheduling a parallel **meeting for property stakeholders** (owners and key neighbors) over the winter.

David will update his list of neighboring property owners for the Chester County barrens properties; Chris will develop a similar list for Lancaster (New Texas) and Cecil Counties (Goat Hill).

BoF, TNC and NCP representatives were excited by the possibility of hosing a **combined timber sale**; no one property is likely to have a sufficient number of trees sized for lumber likely to attract a bidder. BofF will pursue.

#### Goat Hill:

Transfer of TNC-owned land, including the shed, to BoF should be accomplished by early fall.

Board authorizes Chris to provide BoF with **shed combination** and to work out **agreement for shared use of equipment** stored there, including ATV.

BoF taking responsibility for maintenance of the northern serpentine sites.

# **Restoration committee charged with:**

Prepping the Rose Trail and other accessible sites for Jim Herr to mow next March.

Assessing maintenance, restoration needs at site 4.

Work on trail to site 19 and feasibility of establishing trail to sites 13, 12 and 11.

Removing cedars at site 23.

#### NCP:

Ranger support for workdays will be sharply curtailed over the next year. We are open to providing volunteers should Jay contact us with a workday opportunity. Tracy will ask Jay if he would object to our doing a workday without ranger support. Can we devise a plan to remove the debris at serpentine sites in SW corner of Park that minimizes the demands on Park resources?

Until further guidance from Jay, we will not schedule any workdays at NCP.

#### **Lower Chrome:**

Molly will request updated guidance from Pat McIhenny in time for discussion at our September 10 board meeting. The plan is to schedule a volunteer seed collection day in October, followed soon after by a controlled burn of the southern wet land/meadow (definite) and some of the serpentine sites (possible). Pat's team will take responsibility for notifying all local stakeholders. We will try to recruit students from regional universities to participate.

Molly will schedule a trail maintenance work day for November to clear fallen logs, add needed blazes and property boundary signs; and prepare for mowing of the grassland area.

**Serpentine Conference**: The prospect of hosting the International Serpentine Conference was of huge interest to everyone at the August 2 gathering! The timeline for this is approximately six years (we would put in a bid three years from now). We should devote one of our winter board meetings to evaluate an action plan for making this happen.

**Researcher Collaboration**: The barrens remain an underutilized resource for research and teaching.

Once we rebuild our science liaison committee (currently Chris), we will charge it with

• Follow up plans include creating a spreadsheet of research on the barrens. Spreadsheet will include name, org/university, which barrens, which sites, nature of the study, start and end dates, publications/presentations.

- Follow up also includes generating research best practices and protocols for us and for the researchers. Date will include any rules/protocols set forth by the property owners, contact information and how FSLSB will attempt to coordinate, record and present data.
- Clarifying permitting requirements with BoF and other property owners.

**Volunteer Outreach:** We continue to grapple with the challenge of maintaining our serpentine sites with a very small group of dedicated veteran volunteers. As a practical matter, our strategy appears to be

Use our band of dedicated volunteers to tackle critical projects (e.g., failed bridge or downed trees) and to prepare for high yield mowing. Then try to attack large group (e.g. Deloitte), one shot work days to handle labor intensive restorations (e.g., Lower Chrome seed collection, Goat Hill site 23).
