Reports

• Nottingham fair (10/7)

This event, whose location and timing fit nicely with our strategic outreach needs, has fallen short of our hopes for the 2nd straight year.

David will provide Tracy with contact information to meet with Candie Miller, the primary Township point person for the event.

Reimbursement of Harold Sweetman for plants sold at the fair has been deferred as he may donate the small quantity of stock that was sold.

There was some useful intelligence gathering from the event:

Chris is linking Pat and Ann Hughes to representatives from Brandywine Conservancy to ease their property on Gray Horse Road. Chris will explore with Joe Frassetta whether this might be a good time to reach out to the family controlling the last remaining parcel standing in the way of a trail link between Goat Hill and Camp Horseshoe.

PennEnvironment (environmental advocacy organization) might prove a promising partner.

• Chrome firebreak digging (10/12-10/13)

Hoping Kent and Mike W. can provide final update on the status of sits 1-4 going into the burn.

Chris was encouraged by the potential for interesting Cecil Land Trust board member Bill Kilby in potential collaboration -- both in terms of nurturing serpentine sites in Cecil County and organizing events through Cecil Historical Society.

Business

• Southern pine beetle infestation

A large swathe of pitch pine around McPherson Lake is dead. The expectation is that the Park will lose virtually all of its mature population of Pitch and Virginia Pine.

BoF is investing in a drone survey over the next few weeks of dense pine groves in the area (including New Texas and other Lancaster Barrens sites)

We want to stay engaged in the discussions of the response to the challenge. Can we find a way to broker a restoration plan for the Park that actually expands the amount of serpentine terrain accessible to the public?

• Chrome fire outreach

No additional outreach appears needed.

• Stream monitoring at Chrome

David hopes to schedule the next round of monitoring Barren Brook for this month. He will check with Molly to make sure he isn't running into the burn and will email the Board to see if any others wish to join him.

Tracy will continue wooing David Royer to explore possibility of class stream monitoring project to coincide with our data collection effort next April.
